# SUMMARY



The Regional Research Promotion Programme (RRPP) Western Balkans is organizing a fully-funded comprehensive training on social science research methods tailored for junior researchers in the Western Balkans. The course lasts 8 days, and will be held from the **11th** to the **18th April 2016** in Sarajevo, Bosnia and Herzegovina.

According to relevant studies, research capacity in the social sciences in the Western Balkans is underdeveloped. Students and young researchers have low levels of skills and knowledge in research methods, especially when it comes to research design, research techniques, data analysis, and academic writing. There are several reasons for this. First, training in research methods, writing, and analytical skills at university level is often inadequate. Second, there is a lack of opportunities for practicing research methods during one's studies. Third, there is also a lack of relevant extra-curricular training programs in the field. The consequences of this situation have a negative effect on the academic careers of young researchers, the quality of research, and the job prospects for students.

The Research Academy constitutes an educational program that addresses the most relevant aspects of social science research methods and enables young researchers to improve their methodological, analytical, and writing skills. It is designed for junior researchers who are currently working on a research project in the field of social sciences at public or private research centers (higher education institutions, research institutes, think tanks), who have earned their master's degree in the field of social sciences at a university in the countries of the Western Balkans (Albania, Bosnia and Herzegovina, Kosovo, Macedonia, Montenegro, and Serbia), and who live and work in the region.

The Research Academy is designed as a summer school composed of several linked one-day modules. During the program of the Research Academy junior researchers will be guided through all stages of the research process and the sessions will be highly interactive and practice-oriented.

The program will be delivered by a team of 13 trainers who come from a number of European and regional universities and research institutes, with extensive experience in the field of research methods and academic writing.

# BIOGRAPHIES OF TRAINERS

## Dr. Mihail Arandarenko

Mihail Arandarenko is Full Professor of Labour Economics at the Faculty of Economics, University of Belgrade and Chairman of the Board of the Foundation for the Advancement of Economics (FREN). He obtained his PhD from the University of Belgrade in 1998 and spent the academic year 1999-2000 as a post-doctoral fellow at Collegium Budapest – Institute for Advanced Study. He was a Visiting Senior Fellow at the European Institute of the London School of Economics from September 2014 to March 2015. He has published extensively, including the monographs: 'The Labour Market in Serbia: Trends, Institutions, Policies' (2011), 'Mapping the Serbian Labour Market' (2006), 'Development of Social Policy in Serbia and Montenegro' (2003), and 'Economic Theory in Transition' (1997). Prof. Arandarenko's research areas include labour markets, employment programs, industrial relations and social policy. He has been a consultant on short and long term bases for leading international agencies, including the World Bank, UNDP, ILO, EAR, OECD, USAID, etc. He is a member of the SYSDM network of the European Employment Policy Observatory, a project of the European Commission. He served as the Lead Advisor for the implementation of Poverty Reduction Strategy of Serbia (2004-2005), Chairman of the Task Force for the preparation of the National Employment Strategy (2005) and Chairman of the Working Group for the preparation of the Law on employment and insurance in case of unemployment (2009).

## Prof. Simone Baglioni

Simone Baglioni is Professor in Politics at Glasgow Caledonian University (UK) where he is also a research associate at the Yunus Centre for Social Business and Health. Simone holds a PhD in political science from the University of Geneva (CH), a Laurea (degree) in political science from the University of Florence (I) and a PIER certificate from Sciences-Po Paris (F). Before joining Glasgow Caledonian University in 2010, he worked as a researcher and lecturer at various universities (Florence, Geneva, Neuchatel, Idheap-Lausanne, Bocconi, and at the Italian Campus of the Boston College). Simone has directed and taken part in several research projects in the field of employment issues, non-profit organizations/civil society and migration. Currently he is a principal investigator on three EU funded projects: “*Enabling the Flourishing and Evolution of Social Entrepreneurship for Innovative and Inclusive societies*” (EFESEIIS) <http://www.fp7-efeseiis.eu>, “*European Paths to Transnational Solidarity at Times of Crisis*” (TRANSOL) <http://transsol.eu>, Marie Skłodowska Curie/Rise Action comparative project “*For a Better Tomorrow: Social Enterprises on the Move*” (FAB-MOVE). Among his publications are: a co-edited book on civil society in Europe published by Palgrave-Macmillan in 2014, and several chapters and articles in journals such as the *European Journal of Political Research*, *Mobilization: an International Quarterly*, *The International Journal of Social Welfare*, *Social Policy and Society*, *International Review for the Sociology of Sport*.

## Dr. Elona Dhembo

Since 2005, Dr. Elona Dhembo has been a lecturer of Research Methods and Social Policy at the Department of Social Work and Social Policy, University of Tirana. She graduated in 2002 as a social worker from the same department. In 2005 she gained her Master of Science in

Comparative Social Policy from the University of Oxford. She defended her doctorate degree in 2012 studying work-family reconciliation policies in Albania from a gender perspective. Dr. Dhembo currently also acts as RRPP (Regional Research Promotion Program) Senior Advisor for Albania. Her main areas of interest and expertise include research in social sciences, social policy and social services, gender and development issues.

### **Dr. Adnan Efendić**

Dr. Adnan Efendić is an Associate Professor of Economics and head of the Department of Economic Theory and Policy at the School of Economics and Business, University of Sarajevo. Adnan also works as the Editor-in-Chief of the South East European Journal of Economics and Business and is an affiliate fellow at CERGE-EI, Prague. He holds a PhD degree from Staffordshire University Business School, UK. He is an applied economist and his research has been based on different methodologies, including in particular meta-regression analysis, dynamic panel analysis, and structural equation modelling. Most of his research is focused on transition countries, with particular reference to the South East European region. Some of his papers have been published in highly ranked peer-reviewed international journals (*European Journal of Political Economy - EJPE*, *International Small Business Journal – ISBJ*, *Economics of Transition*, *Acta Oeconomica*). The EJPE article was among the most cited articles in this journal in 2015, and his ISBJ paper was nominated for the best research awards at the ISBE 2013 Conference in Cardiff. He is currently working on an international research project focused on social capital, migration and entrepreneurship in the South East European region. ### **Dr. Veronica Federico**

Dr. Veronica Federico is a lecturer at the Department of Legal Studies of the University of Florence, where she teaches Comparative Constitutional and European Law, and a lecturer at Boston College (Massachusetts, USA) in the BC study program in Italy. Veronica obtained her PhD in March 2005 at the Ecole des Hautes Etudes en Sciences Sociales (EHESS) in Paris, with a thesis on South African citizenship. She holds a Diplôme d'Etudes Approfondies, obtained in 1998 at the EHESS, in comparative studies on development, and a Diploma di Laurea in political science from the University of Florence, Italy. In November 2013, she obtained the Italian National Scientific Qualification of Associate Professor in Comparative Law. From 2001 to 2004 she was research associate with the School of Social Sciences, University of the Witwatersrand, Johannesburg. She has obtained several research awards and grants, among which are: an EU funded Horizon 2020 grant (TransSol, grant agreement n. 649435, years 2015-2018) on the theme of transnational solidarity, two grants from the Italian National Council for Research (CNR), a NATO scholarship, a two-year research grant from the United States Institute of Peace (USIP) for a research project on constitutionalism and democratic transitions, with a focus on the South African transition. She has been involved in several national and international research projects. Her research interests include: African Studies; African Comparative Constitutional Law; Fundamental and Human Rights; Constitutional and Democratic Transitions; French Constitutional Law and Politics; Citizenship.

### **Mirna Jusić**

Mirna Jusić has been a researcher at the Center for Social Research Analitika since 2009. Mirna holds an MA degree in Public Policy from the Department of Public Policy, Central European University, Budapest. She also holds an MA Degree in State Management and Humanitarian Affairs, an international joint master program of Sapienza University of Rome, University of Sarajevo and University of Belgrade. She is currently a PhD student in the Public

and Social Policy program at the Institute of Sociological Studies of Charles University in Prague. She has written a number of research reports and articles, *inter alia* in the fields of public administration, local governance and social policy.

### **Dr. Simonida Kacarska**

Dr. Simonida Kacarska is a research coordinator in the European Policy Institute in Skopje, Macedonia. She holds a PhD in Politics and International Studies from the University of Leeds in the UK and a MA in European Politics from the Sussex European Institute. Simonida holds teaching experience at the University of Leeds and her alma mater the American University in Bulgaria. She was a research fellow at the Central European University, University of Oxford, the College of Europe and the European Research Council project The Europeanisation of Citizenship in the Successor States of the Former Yugoslavia based at the University of Edinburgh School of Law. In addition to research experience, Simonida was also a practitioner and has consulted the Council of Europe and the OSCE on matters related to the political transformation and European integration of the Balkans with a focus on national minority policies.

### **Dr. Micaela Mazzei**

Dr. Micaela Mazzei is currently a Research Fellow at the Yunus Centre for Social Business and Health, Glasgow Caledonian University. She studied political science and sociology at the University of Florence. She holds a Master Degree in Applied Social Research from the University of Manchester and a PhD in human geography from Durham University. Dr. Mazzei is currently working on the EFESIIS (*Enabling the Flourishing and Evolution of Social Entrepreneurship for Innovation and Inclusive Societies*) project (FP7) and has extensively researched the social economies of northern English city regions (Greater Manchester and Tyne and Wear) both as an academic and a consultant for a think-tank in Manchester (Centre for Local Economic Strategies). Dr. Mazzei's interest in social economy is threefold: understanding the contextual determinants of social enterprise development and performance; understanding the dynamics of local (and regional) economies – through the lens of a diverse economy approach; and the involvement of social economy organizations in the delivery of public services. She has carried out research on mapping social enterprise activity; developing regional social enterprise support mechanisms; evaluating business support programs and supporting organizational development. Dr. Mazzei also has experience in evaluating programs and projects, and measuring impact. Throughout her consulting career, she has won, managed, and delivered contracts on behalf of a wide range of organizations and agencies, including central government departments, regional development agencies, local authorities and local regeneration partnerships. Dr. Mazzei has also worked as a volunteer Community Grants panelist for the Greater Manchester Centre for Voluntary Organisations (GMCVO), Towpath project (European Social Fund). ### **Amer Osmić**

Amer Osmić works as an Assistant Lecturer (Researcher) at the Department of Sociology, Faculty of Political Sciences, teaching Introduction to Methodology of Social Science, Methods and Techniques in Social Research and Empirical Social Research. He has participated in a number of projects implemented with Association XY, RRPP Western Balkans and Friedrich Ebert Foundation. Mr. Osmić has also participated in numerous scientific and professional

conferences and workshops, and has published a dozen scientific papers and reviews in indexed journals. In 2015 he was visiting Researcher at the University of Lausanne.

### **Dr. Gazela Pudar**

Gazela Pudar Draško (1982) works as a junior researcher at the Institute for Philosophy and Social Theory in Belgrade. Fields of interest are in sociology, such as nationalism, intellectuals, social inclusion and environmental issues. She also deals with youth and policy research. Her doctoral thesis, at the Faculty of Philosophy in Belgrade, was titled "Attitudes of socially - politically influential intellectuals on the national in Serbia after 2000". She is active in the civil society sector, and has been engaged as a consultant/researcher on numerous projects with the Council of Europe, UNHCR, UNDP, NGOs SeConS and Evropski Omladinski Centar.

### **Dr. Michael J. Roy**

Michael Roy is Senior Lecturer (Associate Professor) in Social Business at the Glasgow School for Business and Society and the Yunus Centre for Social Business and Health at Glasgow Caledonian University (GCU), UK. An economic sociologist and public policy specialist, Michael's research interests are interdisciplinary in nature, across political economy, economic sociology and public health, and he is especially interested in how community-led 'bottom up' action can work to address aspects of social vulnerability, which in turn impact upon the social determinants of health and health inequalities. He has particular expertise in qualitative methods inspired by the critical realist philosophical framework and undertook one of the very first Systematic Reviews in the field, the results of which were published in *Social Science and Medicine*. His work has helped to open up a new scientific field of inquiry on the interface between social enterprise and health and well-being, and he has published extensively in this area. Michael serves as Programme Leader for the university's flagship Masters in Science (MSc) programme in Social Business and Microfinance, which was launched in 2014, and is currently involved in a number of high profile research projects. He is presently co-investigator on a project called EFESIIS (*Enabling the Flourishing and Evolution of Social Entrepreneurship for Innovative and Inclusive Societies*), funded by the European Commission's 7<sup>th</sup> Framework Programme, and is co-investigator in another major European project, a Horizon 2020 funded project called TransSol, led by the University of Siegen, Germany, to investigate transnational solidarity, civil society and precarity across Europe since the financial crisis. Michael is also involved in a mentoring a group of researchers involved in social enterprise research in the Western Balkans, funded by the RRPP. Michael has considerable experience in developing and analyzing public policy, having worked in various policy areas including science, innovation, learning and skills, regional economic development and public finance in over a decade with central government in Scotland. He has also served on the board of directors of a number of organizations, including his local Chamber of Commerce, where he was elected Vice President, and set up and ran his own social enterprise for a time.

### **Dr. Lea Sgier**

Lea Sgier is an assistant professor in political science at Central European University (CEU) in Budapest, and a lecturer at the University of Geneva and at the Professional University of Social Work in Geneva (Switzerland). She is also an instructor at the Essex Summer School in Social Science Data Analysis and Collection (UK), the ECPR Winter School in Methods and Techniques (Germany) and the Concordia Workshops in Social Science Research Methods in Montreal (Canada). Her main fields of interest are discourse analysis and interpretive methods,

women/gender in politics and old age (Alzheimer policy and older people's citizenship in particular).

### **Dr. Stephen Sinclair**

Stephen Sinclair is currently Reader in Social Policy in the Glasgow School for Business and Society at Glasgow Caledonian University and a member of GCU's Yunus Centre for Social Business and Health. He joined GCU in February 2006, initially as a Research Fellow in the Scottish Poverty Information Unit. He was previously a Principal Research Officer in the Scottish Government, and before joining the civil service, a Research Associate at the Centre for Research into Socially Inclusive Services at Heriot-Watt University, and a Senior Lecturer in Social Policy at Anglia Ruskin University in Cambridge. He studied for his PhD at the University of Kent (1999), having completed an M.Phil. at the University of Oxford (1991). His undergraduate studies were taken at the University of Strathclyde (1989). Stephen Sinclair's principal research interests include poverty, deprivation and social exclusion. He has also undertaken research on various aspects of financial exclusion, social innovation, public administration and public service reform. He has published five articles, two book chapters and a research report in the last 2 years, and delivered presentations at eight academic conferences and policy events. He also has two books scheduled for publication in 2016 and 2017. He has undertaken research commissioned by the UK and Scottish Governments, Joseph Rowntree Foundation, Nuffield Foundation and European Commission, among other funders, and reviews grant applications for the UK Economic and Social Research Council as well as articles for 11 different international journals. He is a Senior Fellow of the UK Higher Education Academy.
